## **Notice to Operators**

Hotel Room Tax Act

This notice explains that the additional 2% municipal and regional district (M&RD) hotel room tax will continue to apply after the introduction of the harmonized sales tax (HST) on July 1, 2010.

Effective July 1, 2010, the 8% component of the hotel room tax will generally cease to apply to sales of accommodation. For transition rules respecting the wind-down of the 8% component of the hotel room tax, please see our website at www.sbr.gov.bc.ca/business/Consumer\_Taxes/Harmonized\_Sales\_Tax/hrt\_transitional\_rules.htm

However, if you offer taxable accommodation for sale in a participating municipality or regional district, then you must continue to collect and remit the additional 2% M&RD hotel room tax to the province using the *Municipal and Regional District Tax Return* (FIN 401). The form is also available on our website at www.sbr.gov.bc.ca/business/Consumer\_Taxes/Hotel\_Room\_Tax/hrt\_forms.htm

**Please note:** As part of the transition to HST, the provincial hotel room tax will be eliminated from the federal Taxes, Duties and Fees (GST/HST) Regulations. As a result, the additional 2% M&RD hotel room tax will no longer be excluded from the GST/HST base. Therefore, if the accommodation is subject to both the HST and the additional 2% M&RD hotel room tax, the HST will apply to the additional 2% M&RD hotel room tax.
