Processing notices of objection: high-quality service

Revenu Québec favours a cooperative approach in processing your objection to a notice of assessment, so as to keep its commitment to inform you of a decision within six months.

Our aim is to


- have your notice of assessment reviewed by a different work team than the one that issued the notice in order to promote impartiality throughout the process;
- give you the opportunity to be heard;
- allow you to discuss your file;
- provide courteous, personalized service;
- inform you of our decision as quickly as possible.

Have you filed a notice of objection? Be prepared!

By promptly supplying all the information and documents required, you help us provide quick, efficient service.

Help us help you! You must

- submit, along with your notice of objection, a statement of the facts and reasons that justify your position;
- enclose with your notice of objection any documents supporting your claims.



Did you forget to submit important information or documents with your notice of objection?

If so, contact the appropriate Direction des oppositions as soon as possible.

You can be given **reasonable extensions**, depending on the circumstances of your file. Extensions cannot be granted beyond the time frame considered acceptable by the professional in charge of your file.

We must take into account our commitment to inform you of our decision within six months of receiving your notice of objection.

Do you need further explanations?

Direction des oppositions staff will provide the explanations you require upon request.

Do you have a representative?

As a rule, a copy of any correspondence sent to your representative will be forwarded to you.

Avoid having your file closed!

If you fail to present any arguments, a decision will be rendered based on the file as is.

If you cannot provide, within the time limit granted, the information required to process your file at a reasonable rate, the professional in charge of your file may inform you of his or her intention to put an end to discussions. You will then be informed of the decision concerning your notice of objection.

We trust that this document has informed you and convinced you of the importance of your cooperation in the processing of your notice of objection.
